Policy Statement

MF Fasteners is committed to maintaining the highest ethical standards and expects all employees, contractors, suppliers, and affiliates to act with integrity and honesty. This Fraud Prevention Policy outlines the company's stance on preventing, detecting, and reporting fraudulent activities.

Scope

This policy applies to all employees, contractors, suppliers, and affiliates of MF Fasteners, including its subsidiaries and affiliates.

Definitions

Responsibilities.

a. All Employees and Affiliates:

i. Must familiarize themselves with this Fraud Prevention Policy and act in accordance with its guidelines.

ii. Have a duty to report any suspected or observed fraudulent activities promptly.

iii. Should not engage in any form of retaliation against whistleblowers.

b. Management:

i. Must promote a culture of transparency, integrity, and ethical behavior.

ii. Should provide employees with adequate training and resources to recog nize and prevent fraudulent activities.

iii. Must promptly investigate reported fraud cases and take appropriate disciplinary action when necessary.

iv. Shall establish and maintain internal controls to minimize the risk of fraud.

Prevention and Detection Measures.

a. Segregation of Duties: Implement appropriate controls to ensure that no single individual has sole control over critical business processes.

b. Internal Controls: Regularly review and enhance internal controls to minimize the risk of fraudulent activities.

c. Asset Protection: Safeguard company assets, including physical and intellectual property, through appropriate security measures.

d. Financial Controls: Establish robust financial controls to ensure accuracy, transparency, and accountability in financial transactions.
